Pre Race Audits Dates for Circuit Racing

Pre Race Audit system has been improved to assist officials and competitors. Please read the information below and if you have any questions please contact the Club office.

Pre-Race audits do not apply to vehicles that compete in Super Sprints, Hill Climbs, Regularity Trials or Drifting.

Formula Fords, Formula Vee, Formula Class and all Historic classes (except Group N and S) will no longer need an annual Pre Race Audit. Instead competitors with these vehicles will be subject to a full and complete "Race Audit" that will take place at a race meeting on an occurrence of at least every fourth race meeting the competitor enters.

All other circuit racing categories will be subject to a Pre Race Audit every two years. Categories that race in WA have been split into two Pre Race Audit periods to assist the officials. These are:

Categories	Period	Pre Race Audit Year
HQ Holdens, Saloon Cars, Sports Cars, Sports Sedans and Marque Sports Cars	2010 – 2011	2010, 2012 and so on
Historic Touring Cars (Group N), Production Sports Cars (Group S), Improved Production Cars and Street Cars	2009 – 2010	2011, 2013 and so on

Below are the dates set aside for Pre Race Audits for the groups in the period 2010 - 2011:

Please note the first race meeting at Barbagallo Raceway is Saturday 20 February 2009.

Competitor's vehicles must be presented in race ready condition with the vehicle log book. Apparel must also be presented - if not the audit will not be completed and you will need to represent at another scheduled audit session – NOT at the track. A 2010 - 2011 audit sticker will not be issued until such time as this is complete. No Pre Race sticker – no race.

Vehicle owners are responsible for arranging their car to be present, not the person who prepares it.

For any Pre Race Audits after these scheduled dates you **MUST** contact the WASCC for the co-ordinator's phone number. You can not contact any scrutineer - it all **MUST GO THROUGH THE CO ORDINATOR.**
