1. Administration

1.1 Regulations

1.5 Insurance

- b) Every entrant and driver must sign the Disclaimers and Entrants Statement on the Entry Form before taking part in any competition event. This shall include a statement attesting that the entered automobile conforms to its applicable eligibility criteria and is in a fit state for the proposed competition. 1.6 Official Sign-on and Briefing

Officials sign-on details will be communicated via email to all officials prior to the Event.

2. Entries

2.1 Drivers

a) Racing competitors must hold the minimum of a Motorsport Australia Circuit Licence with provisional endorsement. Those with a provisional endorsement must hand their licence passbook to the Clerk of the Course or Deputy Clerk and can be collected from the Race Control at the conclusion of the Event. All Drivers holding Provisional licences must have displayed a 'P' plate on the rear of their

2.2 Entry Lodgement

- a) Entries open on publication of these Supplementary Regulations.
- b) Entry forms are to be lodged via the Motorsport Australia online entry system www.motorsport.org.au/login (Member Portal) before the closing time and date of Wednesday 9AM 11th September 2024.
- c) With the submission of their entry, the competitor(s) give their agreement, also on behalf of their driver(s), pit crew and sponsors, that the organiser may record all activities in connection with the event and have them transmitted by radio, television, or other media. No claims against the Organiseror the transmission company may be raised.
- d) Attendance at the Race Office prior to the driver's qualifying session is still necessary for those competitors who wish to add pit crew to their form.
- e) The Statement of Vehicle Compliance **must** be completed by all competitors by ticking the box via the MSA entry portal.
- f) Late Entries:
 - i. Late entries will not be accepted.

b) Please Note:

- i. All Entry Fees MUST be received on or prior to the closing date of entries of the event.
- ii. A competitor competing in multiple categories must enter both via the MSA portal. To be considered eligible for cross entry two entry fees must be received.
- iii. Any competitor who withdraws from a WASCC event prior to the Event closing date will be entitled to a full refund.
 - Note: all refunds will be processed within 5 working days after the completion of the Event.
- iv. Any competitor whose withdrawal is received after event closing date but before the Event Briefing will incur a \$50 admin fee with the balance to be held in credit.
 - Note: if a WASCC member volunteers as an official for the race meeting, they shall have the full \$50 admin fee credited into their account.
- ٧. No refund credit or other will be offered after commencement of the drivers briefing.

Acceptance and Oversubscribed Entries:

- Where the category entry list exceeds the track density for that category, entries shall be accepted i. based on order of receipt.
- ii. Competitors will be given the option to receive conditional acceptance and be placed on areserve entry list if another competitor withdraws.
- Competitors who do not accept this option will receive a full refund of the entry fee paid. iii.

2.4 Refusal of Entries

- a) The Organisers reserve the right to refuse entry in accordance with the NCR.
- b) The Organisers reserve the right to amalgamate category's event in accordance with CRSR 2.2, the Motorsport Australia Stewards and the Motorsport Australia Safety Division (if applicable).

2.5 General

- a) Trailers, tow trucks and transporters are not to be parked in the paddock area, unless approval has been granted by WASCC.
- b) Loading and unloading of automobiles in the paddock areas must only be done before drivers briefing and after the last race of the day. Automobiles may be loaded prior to the last event in the trailer compound north of the Groundsman's shed or south of the Arise Racing shed.
- Golf buggies and WASCC approved modes of transport "ONLY" are permitted in the paddock area. c)
- This Event may include a parade in accordance with the NCR. d)
- The official noticeboard is located within the Race Office. e)
- Digital noticeboard will be used for all results via https://wascc.com.au/ f)
- Please note Tuning Days are no longer included in Race Entry Fees.

3. Document Check

3.1 Competition Licences

- a) All Drivers will have their Motorsport Australia licences checked through the Motorsport Australia electronic platform.
- b) Drivers must comply to the Motorsport Australia General Appendix Licences document.

3.2 Driver's Briefing

a) A time and place for the Drivers Briefing will be indicated on the timetable.

3.3 Automobile Log book Check

- a) All log books must be submitted to the category-labelled bucket located outside the scrutineering shed.
- b) At the conclusion of the Event, drivers or pit crew must retrieve the logbook from the scrutineering shed.

4. Scrutineering

4.1 Motorsport Australia Targeted Scrutiny

a) Automobiles will be examined throughout the competition as per the Motorsport Australia Targeted Scrutiny Programme.

4.2 Self-Extrication Requirements

a) Competitors may be required to perform a self-extrication test as per Motorsport Australia Self-Extraction Policy.

5. Competition Procedures

5.1 Determination of Winner

- a) The below excludes Rightway Industrial Saloon Cars, See clause S11 of the Rightway Industrial Saloon Car National Sporting Regulations for Determination of Winner.
- b) Points for each race shall be allocated to the driver for each race / trial as per the following table.

- c) The winner will be determined by the competitor with the highest accrued points on the day.
- d) In the event of a tie a comparison of results will determine the outcome with the final event result taking precedence.

5.2 Starting Procedures

- Unless stated elsewhere in these Regulations or Further Regulations all races will be non-championship standing starts.
 - i. For a standing start one (1) crew member per car is permitted to remain on the pit wall to provide directions to the driver until they come under starter's orders.
- b) FSR: All races to commence from a non-championship rolling start as per CRSR 5.5 with the following modifications.
 - i. There will be two (2) formation laps, on the second formation lap each vehicle must form up into a 2x2 formation between Marshall Post 6.5 and 6.7 (where the short circuit re-joins the track), accelerating, braking, and moving left or right must cease beyond Marshall Post 6.7.
- c) Sports Sedans / Sports Cars / WA Muscle Car's: All races to commence from a non-championship rolling

start as per CRSR 5.5 with the following modifications.

- i. There will be two (2) formation laps, on the second formation lap each vehicle must form up into a 2x2 formation between Marshall Post 6.5 and 6.7 (where the short circuit rejoins the track), accelerating, braking, and moving left or right must cease beyond Marshall Post 6.7.
- d) Free Formula: All races to commence from a non-championship rolling start as per CRSR 5.5 with the following modifications.
 - i. There will be two (2) formation laps, on the second formation lap each vehicle must form up into a 2x2 formation between Marshall Post 6.5 and 6.7 (where the short circuit re-joins the track), accelerating, braking, and moving left or right must cease beyond Marshall Post 6.7.
- e) Saloon Cars: As per Rightway Industrial Saloon Car National Sporting Regulations.

5.3 Grid Positions

- a) Unless stated elsewhere in these Regulations or Further Regulations all grid positions will be:
 - i. **First race** from qualifying times, with the fastest qualifier to pole.
 - ii. **Second race** on the finishing order from Race 1.
 - iii. **Third race** on the finishing order from Race 2.
- b) Excel Cup
 - i. **First race** from qualifying times, with the fastest qualifier to pole.
 - ii. **Second race** on the finishing order from Race 1.
 - iii. Third race on the combined points from Races 1 & 2, highest point scorer to pole.
- c) Formula Vee
 - i. **First race** from qualifying times, with the fastest qualifier to pole.
 - ii. **Second race** on the finishing order of 1200's from Race 1.
 - iii. **Third race** on the finishing order of 1600's from Race 1.
 - vi. Fourth race on the combined points from Races 2 1200's, highest point scorer to pole.
 - xv. **Fifth race** on the combined points from Races 3 1600's, highest point scorer to pole.
- d) Saloon Cars
 - Grid position to be determined as per Rightway Industrial Saloon Car National Sporting Regulations.

5.4 i. Grid position to be determined as per Rightway Industrial Saloon Car National Sporting Regulations. Event Lengths

Race lengths for each category will be as follows, with the time commencing at the display of the green flag at pit exit. Unless stated elsewhere in these regulations or further regulations, race lengths for ALL categories will be:

5.5 Timing

a) The Organisers utilise an automatic timing system that requires all cars to be fitted with a Dorian Data-1 transmitter, which is the Competitor's responsibility to be fitted correctly for all sessions.

6. Trophies

Trophies may be presented at the completion of the Event.

- a) Trophies will be awarded as follows:
 - Minimum 3 driver field = 1st place trophy only.
 - Minimum 6 driver field = 1st and 2nd place trophies.
 - Minimum 9 driver field = 1st, 2nd, 3rd place trophies.
- b) Trophies will be awarded as per Category Request forms submitted to the CEC by Category Representatives prior to the commencement of the season.

7. Pit Lane & Paddock

- a) The paddock area is defined as any non-competition area within the facility.
- b) The speed limit within the Paddock area is 15kph.
- c) The Pit Lane speed limit is 40kph.

8. Parc Ferme

Parc Ferme will be in the scrutineering area at the south end of the paddock area.

9. Protests

Protests must be lodged in accordance with the NCR.

10. Integrity

Motorsport Australia's National Integrity Framework and any associated policy (including the Australian Anti-Doping Policy. Motorsport Australia's Illicit Drugs in Sport (Safety Testing) Policy, the Motorsport Australia Alcohol Policy), apply to any activity authorised by Motorsport Australia as published at www.motorsport.org.au.

Any Participant including the holder of a Motorsport Licence (or a Licence issued by another ASN) may be tested for the presence of alcohol, an Australia y drug or other banned substance. In addition to any penalty imposed by Motorsport Australia, a further penalty/s may be applied by Sport Integrity Australia.

Consumption of alcohol in any Reserved Area is prohibited until all Competition is concluded each day.

11. Postponement, Abandonment and Cancellations of Competition

The Organiser reserves the right to abandon, postpone or stop the Event in accordance with the NCR.

12. Smoking

CARCO.com.au Raceway has strict 'no-smoking' areas in accordance with WA statutes and designated areas including the Paddock and pit areas.

Smoking (which includes e-cigarettes and "vaping") and any naked flame is prohibited within 3 metres of any refuelling/defueling operation.

13. Alcohol

Consumption of alcohol in any Reserved Area is prohibited until all Competition is concluded each day.

14. Social Media

All participants are subject to:

 - The Motorsport Australia Social Media Policy (can be found on the Motorsport Australia website).

15. Saloon Cars – Western Nationals.

15.1 Entries

a) Entries will be capped at 38 and accepted in order of receipt.

15.2 Competition Number

- Each Competitor may include their preferred competition number on their Entry Form. a)
- b) The Organiser will have the final discretion regarding the allocation of competition numbers and decide matters when duplicate requests are received.
- c) Each Competitor will be advised of the final decision as early as possible.
- d) The Number 1 is reserved for the previous year's Nationals Winner, if absent the Host state previous Motorsport Australia State Champion may use number 1.

15.3 Sporting Regulations

2024 Rightway Industrial Saloon Car National Sporting Regulations to be conducted as per 2024 Rightway Industrial Saloon Car National Sporting Regulations from Motorsport Australia.

15.4 Garaging

a) Carports will be allocate and available for distribution by Thursday COB 12th September 2024.

15.5 Transporter Parking

- a) Transporters can be parked north of the Arise racing garages.
- b) Trailers may also be left in this area or alternatively in the trailer parking south of the Groundsman shed.

15.6 Camping

a) If you require camping for the duration of the event, please contact Telea (telea@wascc.asn.au) or the WASCC administration office prior to **5pm Friday 13th September.**

16. Formula Vee – Western Nationals.

16.1 Entries

Entries will be capped at 38, combined 1200's and 1600's, accepted in order of receipt. a)

16.2 Competition Number

- Each Competitor may include their preferred competition number on their Entry Form. a)
- b) The Organiser will have the final discretion regarding the allocation of competition numbers and decide matters when duplicate requests are received.
- c) Each Competitor will be advised of the final decision as early as possible.
- d) The Number 1 is reserved for the previous year's Nationals Winner, if absent the Host state previous Motorsport Australia State Champion may use number 1

16.3 **Fuel**

- a) With the exception of Ethanol content Fuel must be compliant with 2.1 PUMP FUEL in Schedule G of the Motorsport Australia Technical Appendix.
- b) Maximum permitted ethanol content is 0% Ethanol Blended Fuel is strictly prohibited.
- c) Fuel may be sampled in accordance with 9 FUEL TESTUNG in schedule G of the Motorsport Australia Technical Appendix.

16.4 Garaging

- a) Infield Garages will be allocated and available for distribution by Thursday 12th September at 1pm.
- b) Bump in for Infield Garages will be available as per below:

Thursday 12th September – 1600pm – 1800pm.

Friday 13th September – 0700am – 0800am then 1630pm –1800pm.

16.5 Tuning day

- a) Fridays Tuning day will be conducted out of Outfield Pitlane.
- b) All competitors must be located outfield prior to 0830am for the commencement of Tuning day.
- c) There will be no vehicle movements on the infield between 0830 and 1600 during the Tuning day.
- d) Vehicles will not be released from infield pitlane during the Tuning day under any circumstances.

16.6 **Transporter Parking**

- a) Transporters can be parked north of the Arise racing garages.
- b) Trailers may also be left in this area or alternatively in the trailer parking south of the Groundsman shed.
